

PRIVACY POLICY

1. Who we are?

Albert Trading Ltd is a privately-owned and is duly registered under the laws of Mauritius with its registered office situated at 17, Brabant Street, Port Louis, Mauritius.

2. Why the Privacy Policy?

The Data Protection Act 2017 is designed to strengthen the controls and personal autonomy of individuals over their personal data, in line with current relevant international standards. The Privacy Policy adopted by Albert Trading Ltd describes how we collect and use Personal Data of individuals during the period in which we are engaging with them on a business to business basis as well as on our websites.

3. What is personal data?

Personal data refers to any information relating to an individual that the latter has provided in the context of his personal needs. These include for e.g. his name, address, contact details, etc.

4. When does Albert Trading Ltd process your personal data?

- f) When you provide your information in any other way. When you visit our website, the web server automatically collect anonymous information such as log data, browser files, IP addresses, current location, referring/exit pages etc. Our website uses cookies to make your browsing experience more enjoyable.
- 5. Why does Albert Trading Ltd process personal data?

The Privacy Policy explains the purposes for which Albert Trading Ltd processes personal data with a view to fulfil its duties and responsibilities, which includes amongst others:

- a. To fulfil any contractual obligations, we have with you, or
- b. It is our legal duty, or
- c. You consent to it.

In any event, Albert Trading Ltd is committed to ensuring that the information it collects and processes is appropriate for the purpose for which it was collected. Albert Trading Ltd reassures its clients that any disclosure or transfer of personal data to third parties and/or to different countries will only be done if it fits under any of the above purposes.
