We must approve your application before you have authorization to order from our online wholesale shopping cart. We will notify you of approval upon verification of your information.

**Distributorship**

CanCigs (CanCigs.ca) appoints resellers as non-exclusive distributors in the market for products made available on our website.

## **Prices**

Wholesale products and prices on the Cancigs.ca wholesale pages are subject to change without notice.

## **Payments**

All payments are processed online through our wholesale shopping cart and are payable by credit card. We accept Visa or Mastercard. Our maximum allowable daily limit per credit card transaction is \$2,000.00. If you need to purchase in higher dollar values you would have to purchase products over consecutive days. ## **Damage claims**

CanCigs makes every effort to ship our products safe, securely and adequately insured. Cancigs will not be liable for damages incurred during transit. If in the event a shipment arrives damaged you agree to contact the shipper and Canigs within 48 hours of delivery. You also agree not to cancel or contest any payment made to CanCigs as a result of a damage claim. The shipper will conduct a full investigation into the damage claim; once the issue has been resolved we will contact you to arrange for a replacement of the damaged products.

## **Returns**

Unless defective or damaged CanCigs will not accept returns for any other reason, all claims for damage must be made within 48 hours; any claim for defective merchandise must be made within 15 days of receipt. All returns must be approved by CanCigs in advance and we will not refund the cost but rather replace the affected merchandise.

The relationship between CanCigs and yourself is nothing more than that of a seller and a distributor and in no way shall you be considered a representative of CanCigs.

## **Warranty to reseller**
