Product Description

Organic, gluten free porridge mix with oats, dates, almond flour and chia seeds. Additional topping, consisting of toasted almond flakes, cane sugar and freeze-dried raspberries.

Ingredients

Porridge mix: 56% gluten free **oats***, 24% dried dates*. 10% **almond** flour*, 8% chia seeds* (Salvia Hispanica), salt.

Topping: 54% toasted **almond** flakes*, 33% cane sugar*, 13% freeze-dried raspberries*.

Storage

Dry and not too warm.

Sensory Evaluation

Aroma: Sweet smell of oats, almonds, and delicate raspberry.
Taste: Mild and round taste of oats and almond supplied with fresh tartness from the raspberries and a hint of umami from the toasted almonds.
Texture: Porridge: Creamy and velvety. Topping: Crisp and crunchy.
Appearance: Porridge: Beige, homogeneous mass. Topping: Beige almond flakes and smaller red bits of raspberries.
