Product Description

Ingredients

Porridge mix: 56% gluten free **oats***, 24% dried dates*. 10% **almond** flour*, 8% chia seeds* (Salvia Hispanica), salt.

Topping: 50% dried dates*, 19% crushed cocoa nibs*, 31% toasted coconut flakes*.

Sensory Evaluation

Aroma: Sweet smell of oats and coconut combined with delicate cocoa.
Taste: Mild oat and almond with extra sweetness from toasted coconut flakes and umami from the cocoa nibs.
Texture: Porridge: Velvety and creamy. Topping: Crisp and crunchy.
Appearance: Porridge: Beige and homogeneous. Topping: Dominated by brown nuances from dates and cocoa nibs with long specs of beige coconut flakes.
