Product Description

Organic, gluten free porridge mix with oats, dates, almond flour, and chia seeds. Additional topping, consisting of toasted almonds, cane sugar, freeze-dried currants and cinnamon.

Ingredients

Porridge mix: 56% gluten free **oats***, 24% dried dates*. 10% **almond** flour*, 8% chia seeds* (Salvia Hispanica), salt.

Topping: 33% toasted **almonds***, 33% cane sugar*, 26% freeze-dried black currants*, 2% cinnamon*.

Storage

Dry and not too warm.

Aroma: Sweet smell of oats and almonds with a hint of cinnamon.
Taste: Mild and round oat and almonds flavor with balancing tartness from black currants and umami from toasted almond flakes and cinnamon.
Texture: Porridge: Velvety and creamy. Topping: Crisp and crunchy.

Appearance:

Porridge: Beige, homogenous mass. Topping: Dominated by light brown nuances from almond flakes and cinnamon-sugar with specs of black from the black currants.
