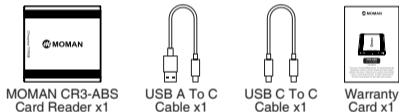
3 in 1 Card Reader

User Manual

Thank you for choosing MOMAN product. This manual describes the specifications, functions, connection methods and matters needing attention of the product. Please be sure to read this manual carefully in order to use this product correctly. In addition, please keep this instruction manual properly and read it again when necessary.

The MOMAN 3-in-1 Card Reader is a convenient way to quickly transfer files between multiple cards and your computer. Using USB 3.1 Gen 2 (USB 3.2) technology, it provides high-speed file transfers of up to 312MB/s for SD storage cards and up to an impressive 1250MB/s for CFexpress storage cards. This greatly enhances your workflow, allowing you to maximize the speed and bandwidth of your USB 3.2 desktop and laptop computers. It also supports CFexpress Type A, CFexpress Type B, SD, SDHC, SDXC, SD UHS-I, and UHS-II storage cards, making it an excellent choice for professionals looking to significantly improve their work processes.

Precautions for Safe Use

7. Avoid dusty areas.

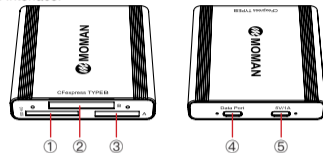
Note: the product will get hot after long-term use, please handle with care. (Risk of burns).

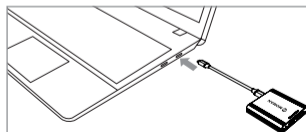
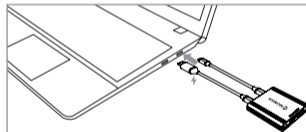
Compatible models (USB Type-C)

1. This product supports laptops or iMac running Mac OS and Windows with Type-C interface USB 3.2 Gen2 (USB3.1 Gen2) or above.
2. iPad Pro 2018 and upgraded iPad Pro2022
3. Phones and tablets that support DP Alt Mode

Operations

No need to install any drives. Instructions for use:

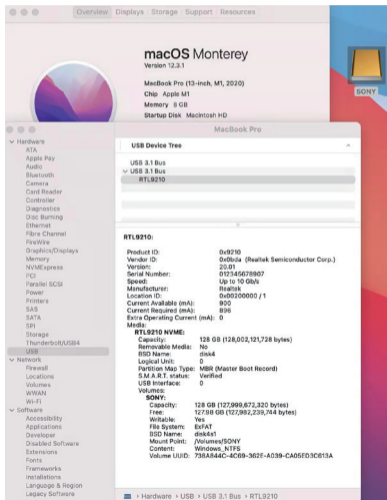
1. After installing the memory card correctly, connect the device with a cable.
2. Under Windows system, you can set the "Deletion Policy" of the memory card to "Better Performance" and check "Enable on-device write cache" in the "Write Cache Policy" to obtain better read and write performance. .
3. Please choose a USB interface with sufficient power supply to connect the card reader.
4. When the power supply cable is connected, the data cable no longer provides power to the card reader and only transmits data. If the power supply cable is unplugged first, the data cable must be re-plugged and unplugged before use.
5. At the end of use, please "safely remove the hardware device and eject the media" before removing the memory card.



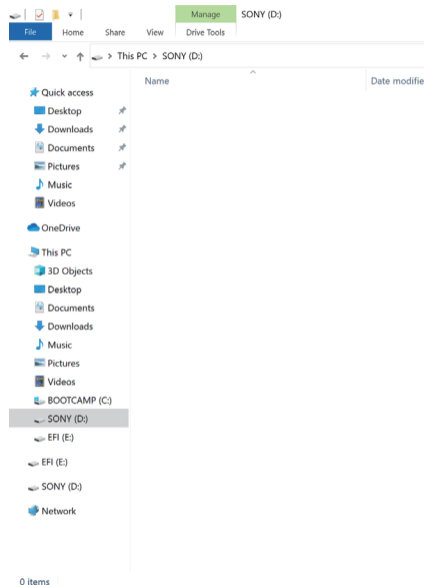
The way of MAC OS verifying interface:

Click to open the device description about USB in System Information. Check to see whether the reading device is mounted in the correct position

(Note: There will be deviation between speed measurement and actual speed.)

Specification

Interface Type: CFexpress Type-A / CFexpress Type-B / SDHC UHS-II (SD 4.0)

Import: 5V/1A

Theory Speed: 10Gbps

NOTE: The actual transmission speed varies with the memory card and the device used.

Q&A

Q: Is this product compatible with XQD memory card?

A: This product only supports CFexpress Type-A, CFexpress Type-B, SDHC UHS-II memory card.

Q: I have a CF card. Is the card slot of the card reader suitable?

A: They won't be compatible because the card slot is different.

Q: What brands of memory cards are supported by this product?

A: This product supports SanDisk, LEXAR, SONY, ProGrade and other popular brands on the market.

Q: Is the product heating normal during use?

A: It is normal. Since the CFexpress memory card is a high-speed card and the built-in chip in the card reader needs to work, it will emit heat, which is normal behavior. Please don't worry about it.

Q: Can my memory card be connected to the host for a long time through the card reader?

A: It is not recommended to do so, because CFexpress memory card is a high-speed card. Long-time reading will cause certain damage.

Warranty

Within 1-YEAR warranty period(starting from the order day), any defect caused under p, we offer free repair or replacement of spare parts.

The following conditions are not covered by the warranty.

1. When the warranty card and the faulty product cannot be submitted.
