2. Customer can take up to three paddles and up to 2 days (7 days for shipping customer), \$15.00 deposit per demo for 2 (7) days. \$15.00 demo deposits become a credit on the customer's account and can be applied towards a paddle purchase within 60 days.
3. If customer want to try more paddles or if you want to try longer period, we offer paddle rental service, the rental fee is \$5 each paddle per day.
4. If customer chooses the demo program and you are late to return the paddles after 2 (7) days, the customer's demo program will automatically turn to rental program, and the rental fee will be charged from customer's authorized credit card until customer returns the paddle. If you return them late and we are unable to reach you, we will charge your credit card for the full retail price of the all the paddles. 5. Damage to the paddle shall be compensated at retail price (Except for normal wear and tear during use)
