1. Eligibility:

Outerknown WSL Surf Ranch Day Giveaway (the “Sweepstakes”) is open only to those who sign up at the sweepstakes page located at outerknown.com/pages/wsl and who are 18+ as of the date of entry. The sweepstakes is only open to legal residents of United States (EXCLUDING RESIDENTS OF NEW YORK AND FLORIDA) and is void where prohibited by law.
