



Hours of Operation: Monday through Saturday with a closing time of 1:00am

Wine Cellar Rental (includes onsite Wine Cellar Manager and Kitchen Porter as well as Gosling's Wine Cellar Tables, Chairs, Linens, & Glasses)

- **Tier 1: For a maximum of 50 people: \$1,500.00**

Events exceeding the 6hr allotment may see additional charges.

Additional Staffing (minimum of 3 hours): Bartender: \$50 per hour

Catering: Clients are responsible for arranging a reputable caterer for your function. **Gosling's must be informed and approve your choice of caterer**, as well as review the menu in advance to ensure we are providing the best wines to complement the meal. We can provide you with a listing of caterers that are familiar with our facilities.

GOSLING'S WINE CELLAR FEE, DEPOSIT & CANCELLATION POLICY

- For alternatives to house selections and wines for Napa Tech Tastings, wines will be charged at Gosling's Limited retail prices, and a minimum of \$40.00 per bottle
- Breakages will be charged to the customer in accordance with the normal rates for breakages at Gosling's Limited.
- Gosling's Limited accepts no responsibility for the performance of the caterer. Any disputes over catering should be directed to the Catering Company supplying the service.
- Closing time for Gosling's Wine Cellar is 1:00am, and all guests and staff must be off premises at this time.
- **To secure a booking: A \$500.00 non-refundable deposit is required to secure a booking. On agreement of the confirmed event with signed contract 75% of the estimate must be paid 21 days prior to the event or the booking will be automatically cancelled.**
- For cancellations on confirmed events with signed contracts below \$5,000, received 14 days before the event date, customers will be charged \$100 administration fee.
- For cancellations made 24 hours or less before the event, the customer will be charged in full.
- All beverages must be supplied by Gosling's Limited.
- We reserve the right to stop service in compliance with the Bermuda Liquor Licensing laws. No person under the age of 18 will be served alcohol. No one deemed to be intoxicated will be served alcohol.
- Under no circumstances should any decorations be attached to any part of Gosling's Wine Cellar with nails or screws or staples and not with any tape that may affect the paint on the walls.
- Gosling's Limited will inspect and control all functions in Gosling's Wine Cellar. Any damage to the cellar will be billed to the customer. Gosling's Limited will not be responsible for any items lost or stolen in Gosling's Wine Cellar.
- Also Gosling's Limited will not be responsible for any personal injury during or after an event in Gosling's Wine Cellar.
