### **CONTESTANT TO SUPPLY:**

- One prepared recipe for Panel Judging
- 30 additional bite size samples
- Hot plates or cold plates to keep the dish at proper temperature
- Utensils for serving samples, including knife, spatulas, tongs, etc.

### **SPONSOR TO PROVIDE:**

- Eating Utensils for sampling
- Small plates and/or cups for bite size samples
- Napkins
