2. Avoid exposure to direct Ultraviolet Light. If the device is not working contact support at: (949) 267-9095



3. **Do not override safety interlock.**

4. Intended for indoor use only.



5. Do not alter the design or construction as it may cause an electrical problem.

6. Do not use this product in any other use than its intended purpose, as described in the user manual.

7. Disclaimer, UV Light contains **Mercury.**

10. We advise the customer to not use the product in small areas, since the product produces Ozone. Exposure to ozone can result in respiratory problems

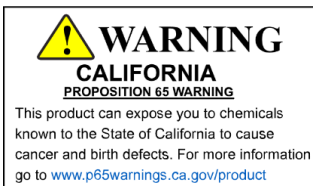

# Installation

---

**Air Sanitize** is a portable device and no professional installation is needed.

1. Position the Air Sanitize device in the desired location.
2. Remove the wrapping or protective layer from the unit.
3. Plug power cord into the electrical outlet.
4. Operate the motion control with a click.
5. The device will automatically turn off when no one is around!

# Instructions

---

The device is very easy to use and only needs to be plugged in. If you experience a stall in starting, do not



turn on and off to avoid overheating or electrical malfunction.

**Do not override the safety interlock switch. Operation of the fixture with the interlock switch overridden and the Access Door open will expose personnel to direct or strongly reflected germicidal ultraviolet rays.**



**Germicidal ultraviolet rays are harmful to the eyes and skin. Do not Shake the device when operating, it may cause rupture of the UV Lights.**

One (1) year Limited Warranty from the date of original purchase. Filter change must be done every (1) year if heavily utilized. **We do not recommend any unionized maintenance service.**
