

Mamas & Papas & iCandy Orange Event Terms & Conditions

- This promotion is open to residents of the UK, Channel Islands, Isle of Man and the Republic of Ireland, aged 18 years or over. This Promotion is not open to employees or agents of the organiser; Mamas & Papas (Stores) Limited, a company incorporated in England and Wales with company registration number 12278537 and whose registered office is situated at Colne Bridge Road, Huddersfield, HD5 0RH, or any of its associated companies ("Mamas & Papas").
- 2. This is a promotion that requires participants to make a purchase to receive either a gift with their purchase or a goody bag. By entering this promotion, participants agree to be bound by these terms and conditions.
- To be eligible to receive a free gift with purchase or a goody bag, simply go to one of the five (5) participating stores including Blanchardstown, Gateshead, Nottingham, Trafford or Thurrock ("Selected Stores"). Entry is by in-person purchases made at Mamas & Papas Selected Stores only. Please check for your nearest Selected Store and their opening time here.
- 4. The promotion has two ways a customer can enter to receive a gift or a goody bag ("**Gift or Goody Bag Promotion**").

Gift with Purchase

- 5. In order to qualify for the gift with purchase promotion, the customer must make a purchase of an iCandy Orange 4, pushchair only or pushchair bundle in any of the Selected Stores between 22nd April 2024 and the 28th April 2024, together the ("Qualifying Purchase Period").
- 6. Once the customer has purchased an iCandy Orange 4 pushchair at one of the Selected Stores between the Qualifying Purchase Period, the customer will receive on the day of their purchase a free gift, which will include a black parasol and clamp ("**Gifts**").
- 7. Please note that there are only 10 Gifts per each of the Selected Stores. Incomplete purchases at the Selected Stores between the Qualifying Purchase Period will not count. The Gifts will be handed out on a first come first serve until all stock has been issued.

<u>Goody Bag</u>

- For the goody bag promotion, the Selected Stores will be running the promotion in our Nottingham store on the 22nd April 2024 only, all other Selected Stores will be running the promotion on the 25th April 2024 only ("Respective Store Promotion Date").
- 9. In order to receive a goody bag, the customer must purchase any iCandy product at any of the Selected Stores on their Respective Store Promotion Date (detailed in clause 8) to receive a goody bag ("Goody Bag Promotion Criteria"). The goody bag may include gifts such as a tote bag, water bottle, trolley coin, *Baby on Board* sign, notebook and pen ("Goody Bag").



- 10. Please note that the Goody Bags in each of the Selected Stores are limited to 15 Goody Bags each. Any incomplete purchases at the Selected Stores, on their Respective Store Promotion Date will not count. The Goody Bags will be handed out on a first come first serve until all stock has been issued.

For this Gift or Goody Bag Promotion, only the purchase of an iCandy product or an iCandy Orange 4 pushchair is taken into consideration during the Qualifying Purchase Period for the purchase with gift or Respective Store Promotion Date for the goody bag. Customers cannot include past or future purchases made prior or after the Qualifying Purchase Period.
