Policies and Terms of Consignment Contract

Below are the terms and conditions of consignments for Share the Love Consignment, North Andover, MA.....

We will accept current women's fashions, activewear, shoes, handbags and accessories that are in excellent resale condition only. All garments must be in rack-ready condition – clean with no stains or deodorant marks, ironed with no holes, snags or pilling. We will return your hangers to you before you leave upon request. We have the right to refuse any item we feel will not sell in our store. If an item is left for consignment and we determine it has a defect as stated above, we will automatically donate the item. No exceptions, so please check your items carefully before your appointment.

Our terms of the consignment contract are for 60 days if you choose to pick up your items at the end or 90 days if you choose to donate your items at the end. Should you choose to pick up your unsold items, it is your responsibility to collect them within 15 days of the end of the 60 day period and you may not be notified so please be sure to mark your calendar with your contract end date. When picking up your unsold items, we ask that you give us 24 hour notice to locate the unsold items in the store and remove them from our system and you may need to assist us in collecting them. There may be items we are able to keep for longer than 60 days but that will be at the discretion of the Share the Love staff at that time. All items that are not picked up within the defined timeframe become the property of Share the Love Consignment and the disposition of those items is at the sole discretion of Share the Love Consignment.

While we do our best to keep your consigned items safe, all consignments are left at the owner's risk. Share the Love Consignment is not responsible for loss, theft, fire or any other damage while in our possession. Our store is insured, but your merchandise is not since it is not owned by us, as this is the insurance company's policy. Share the Love is not liable for any loss while your merchandise is under consignment.

Our 60 Day consignment payout is as follows:

• Day 1-30 you will receive 40% of the sales price for items sold under \$100 and 50% of the sales price for items sold over \$100, minus any taxes or fees

• Day 30-60 your item will be discounted 20% and you will receive 40% of the sales price for items sold under \$100 and 50% of the sales price for items sold over \$100, minus any taxes or fees

Share the Love makes their best effort to merchandise, sell and care for all consignments. We will determine the best price for each item, researching where necessary, and price it accordingly. All items are marked down 20% after 30 days and we reserve the right to include the item(s) in special sale events and promotions at any time. Should you choose not to include your items in an upcoming sale, please be sure to come in and collect your items prior to the markdown period.

Pay Out:

Checks will be cut at the request of the consignor after the 60 or 90 day contract period is complete, as long as your credit balance is \$25.00 or more. If you do not request a check at that time, your funds will remain in your account and can be picked up at a later date or used to shop within the store.

By agreeing to these contract terms, you are confirming that all items consigned for sale are lawfully and solely owned by you, or as an agent acting on authority given to you, to sell such merchandise. By submitting your items for sale, you are verifying that they are genuine, authentic and not counterfeit. A \$25 fee will be collected up front to allow us to authenticate any designer accessory that does not come with a certificate of authenticity.

We accept current women's fashions, activewear, jewelry, shoes, bags and scarves in excellent resale condition. We **DO NOT** accept bathing suits, wedding dresses, MOB dresses, lingerie, undergarments, or any real gold or diamond jewelry.

Your items must be **CLEAN, PRESSED, FREE OF SMELLS** and anything that wrinkles must arrive on **HANGERS**, which will be returned to you upon request before you leave. We will only accept clothing that does not wrinkle, like sweaters and pants, in bags or boxes. If an item is left and we discover deodorant marks, a stain, hole, missing button, etc, your item will be donated right away to a local charity so please look over your items carefully before your appointment.

If you have more than 20 clothing items to consign, please inform the store at the time of booking the first appointment so arrangements for a second appointment can be made.

I will pick up my unsold merchandise in the store at the end of my 60 day contract.

______ I will not pick up my unsold merchandise at the end of my 90 day contract and I understand that my items will become the property of Share the Love Consignment at that time and donated to a local charity if unsold.

*If no line is checked above, your items will automatically become the property of Share the Love Consignment 90 days from your appointment date above.

NOTE: If you choose to pick up your items at the end of your 60 day contract, please inform us within 24 hours of when you are coming to allow time for us to collect your items in the store and remove them from our system or you will need to assist us in locating them. There may be items we are able to keep for longer than 60 days but that will be at the discretion of the Share the Love staff at that time. I understand I may not be notified at the end of 60 days so please be sure to add the contract end date to your calendar.
