## Children’s Blanket Sleepers and Robes Recalled Due to Violation of Federal Flammability Standards and Burn Hazard; Imported by International Intimates Inc.

### Recall Summary

**Name of Product:**  Children’s Blanket Sleepers and Robes.

**Hazard:** The recalled children’s blanket sleepers and robes fail to meet the federal flammability standards for children’s sleepwear, posing a risk of burn injuries to children.



### Remedy: Refund

Consumers should immediately take the recalled children’s blanket sleepers and robes away from children, stop using them and contact International Intimates Inc. for instructions on how to dispose of the pajamas for a full refund. Consumers should destroy the garments by cutting them in half and send International Intimates a photo of the destroyed recalled product by email at [recall@renerofe.com](mailto:recall@renerofe.com). Upon receipt of the photo, consumers will be issued a full refund of the purchase price.

### Recall Details

**Units:** About 37,800

**Description:** This recall involves  Children’s Blanket Sleepers and Robes. The children’s sleepwears are made of 100% Polyester and were sold in sizes 6 to 14. The blanket sleepers and robes were sold in several different prints; pink/orange tie dye, green/pink tie dye, pink/white hearts, grey/pink leopard, grey/orange fox, grey/pink dog, black/white panda, pink/white panda, blue/white fair isle. The blanket sleepers and robes are hooded with an embroidered animal face on the front of the hood. The neck label states  and includes the garment size, style # 426989 or 436989, and PO JZJ0005. The inside neck label includes the washing instructions, “Date 6/1”, and one of the following GPU #’s: ACG2101, ACG2102,

ACG2103, ACG2104, ACG2105, ACG2106, ACG2107, ACG2108, ACG2109, ACG2110, ACG2111, ACG2112, ACG2113, ACG2114, ACG2115, ACG2116, ACG2117, ACG2118.
