



What's in the Box



Getting to know your Video Conference System 360



Zoom-in





Zoom-out

Tap to zoom out

View mode

Tap to change between camera view modes

Connect with new Bluetooth device

Press and hold to enter Bluetooth pairing mode to connect with a new Bluetooth device

Disconnect or reconnect with Bluetooth device

Tap to disconnect or reconnect with a paired Bluetooth device

O Off

Purple Not connected to any Bluetooth device Connected to at least one Bluetooth device * Flashing Blue Speaker is in Bluetooth pairing mode

Press and hold for 3 seconds to turn SC360 on/off



Mute

Mute microphone

Voice quidance

Press and hold for 10s to turn voice guidance on/off




Volume up Tap to increase volume Volume down Tap to reduce volume

Getting Started


Turn on the SC360

- · Remove the camera cover from SC360 conference speaker
- Plug the included power adapter into a power outlet and connect the other end to SC360
- Press and hold [(1)] on the top of the speaker for 2 seconds to turn SC360 on and 3 seconds to turn it off.



Connect SC360 to your computer

- Plug the included USB cable into your computer and connect the end with the type-C connector to the SC360.
- Select SC360 as the default microphone and speaker source. Select the SC360 as the default camera source.



Connect SC360 with a Bluetooth Device (Audio Only)

- Press and hold [🔻] for 3 seconds until the Bluetooth LED on SC360 begins flashing. You will hear connection guidance voice prompts.
- Enable Bluetooth on your Bluetooth device.
- Select SC360 from the list of available Bluetooth devices to connect.
- You will hear the SC360 say "Connected".
- Tap [★] to disconnect with connected Bluetooth device.







Mute/Unmute

• Tap [₺] while calling to mute or unmute the microphone.

Change Between View Modes

• When the SC360 is connected to your computer and is streaming video, tap [1] to change to another view mode. The SC360 has four different view modes, select the one that best suits your meeting environment.







Split - The top and bottom panels will each show a 180 degree view. Focus - This mode will automatically focus on whoever is speaking. Grid - The room is split into 4, the focus will be on the person speaking Panorama - The top will display a 360 degree view, while the bottom will display up to 2 people speaking.

While in Focus, Grid, and Panorama modes, tap [♠] or [♠]

Hold Camera View

- · During a call, you may press and hold the [] button for 3 seconds. This will stop the camera from voice tracking, regardless of the mode it is in.
- Briefly press the [🔝] button again to enable voice tracking again.



Adjust Voice Tracking Sensitivity

• If the voice tracking on your SC360 is too sensitive, you can adjust it. Press and hold the $[\mathfrak{D}]$ and $[\mathfrak{D}]$ buttons together, and it will cycle from High to Low. Medium, then back to High.
