किसान मूल गिरदावरी के साथ अंकित क्रमांक एवं दिनांक भी करें अपलोड

जयपुर। प्रदेश में समर्थन मृल्य पर मंग, उडद, सोयाबीन एवं मंगफली की हो रही खरीद के लिए 31 अक्टूबर तक 3 लाख 56 हजार 665 किसानों ने पंजीयन करवाया है। राजफैड द्वारा रेण्डम जॉच के दौरान यह तथ्य ध्यान में आया है कि कई किसानों द्वारा मूल खसरा गिरदावरी की प्रति पी 35 अपलोड नहीं की गई है। किसान पी 35 गिरदावरी के साथ उस पर अंकित क्रमांक एवं दिनांक को भी अपलोड करे ताकि पंजीयन मान्य हो सके एवं खरीद भी संभव हो सके। यह जानकारी गुरूवार को राजफैड की प्रबन्ध निदेशक डॉ.

वीना प्रधान ने दी। डॉ. प्रधान ने बताया कि पंजीयन की प्रकिया लगातार जारी है। उन्होनें बताया कि किसानों द्वारा ऑनलाईन पंजीयन की रेण्डम जॉच के दौरान प्रारम्भ के तीन जिलों

सवाईमाधोपुर, जैसलमेर एवं नागौर में यह पाया गया कि इन जिलों में एक मोबाईल नम्बर पर चार या अधिक किसानों के नाम पंजीकत हुए है इनमें जैसलमेर में 257. सवाईमाधोपुर में 649 तथा नागौर जिले में 733 मोबाईल नम्बर से चार या अधिक किसानों ने पंजीकरण किया है।
