Furthermore, for the purpose of such Buy Back proposal, the Board will consider and approve the Audited Financial Results of the Company for the Half Year ended on September 30, 2023 along with Statutory Auditor's Report thereon.

Further, in continuation to our intimation of Closure of Trading Window dated September 29, 2023 and pursuant to Company's Code of Conduct to Regulate, Monitor and Report Trading by Designated Persons and their Immediate Relatives, the trading window for dealing in the securities of the Company has been closed from October 01, 2023 and will continue to remain closed till 48 hours after declaration of the results. Accordingly, the trading window shall re-open from November 14, 2023.
