3. I have not verified the correctness and appropriateness of financial Records and Books of Accounts of the listed entity.

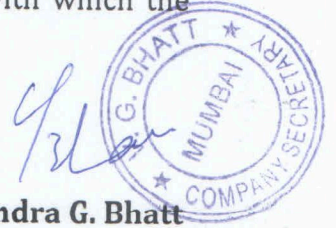
