Pursuant to Section 108 and 109 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended (hereinafter referred to as 'the said rule') and in accordance with the SEBI(Listing Obligations and Disclosure Requirements), Regulations 2015, the Board of Directors of ELEGANT MARBLES AND GRANI INDUSTRIES LIMITED (hereinafter referred to as the 'Company') has appointed me as the Scrutinizer for the Remote E-Voting process as well as to scrutinize the poll papers received from the members at the venue of the Annual General Meeting (AGM).

- The Agency / Service Provider had set up electronic voting facility through the website www.evotingindia.com. The RTA had uploaded all the items of the business to be transacted at the AGM on the website of CDSL to facilitate the members to cast their vote through Remote E-Voting.
- The cut-off date for the dispatch of the Notice of the AGM was 25th June, 2016(Physical & Email) and as on that date, there were 1795 members of the Company. RTA had sent the notice of the AGM containing inter-alia process and manner for availing e-voting facility by E-mail to 810 members who's Email ID were made available by the Depositories and for those members, holding in physical form, who had registered their Email ID with the RTA. In respect of 985 members, who's Email IDs were not available, the notice of AGM were sent by Courier. In respect of 28 bounce back cases, where transmissions through Email had failed, the Company had sent physical copies of the notice of the AGM by Courier.

- At the venue of the 31#AGM of the Company held on Tuesday, 19th July, 2016, the facility to vote through Poll Paper was made available to those members who were present at the meeting but who did not participate in the process of Remote E-voting to cast their vote.
