2. Minimum order is 100 units of a single SKU. A single SKU is defined as a kit comprised of the same bag/tin, contents, and decoration.
3. Distributor must obtain from the logo's owner, and indemnify Pinch from any and all consequences of unauthorized use.
4. The set-up fee is $\$ 100$ for custom imprints and $\$ 100$ for custom paper sleeves. Set-up fee is non-refundable and includes one round of revisions to the digital proof. Additional revisions will be billed at $\$ 50 /$ hour.
5. Three types of samples are available: Virtual, Standard, and Custom.

- Virtual samples are digital proofs of the bag with the customer's logo, and they are provided free of charge.
- Standard samples are physical samples decorated with a generic logo. Standard samples cost \$10/unit.
- Custom samples require pre-payment of the appropriate set-up fee, which will be applied upon placing an order. Custom samples are $\$ 10$ each.

6. We require a deposit equal to $50 \%$ of the total order upon placement; the balance of the invoice will be charged one day prior to shipping.
7. For items in stock, please allow 5-10 business days for order processing for most orders. Order processing will begin at 9 a.m. CST on the next business day following proof approval. Order processing time does not include shipping time. If the size of your order requires a longer processing time, your sales representative will inform you of a revised timeline.
8. We will ship directly to the distributor or end-consumer. We cannot drop ship single units at this time; the complete order must be shipped to one destination.
9. All sales are final.
10. Pinch Provisions reserves the right to review any and all potential customers to determine account eligibility. This includes, but is not limited to, the policies stated within this document.
11. Certain products are eligible for sale in Canada, the UK, France, and Australia. Distributors wishing to ship to these regions must obtain prior written approval from a Pinch representative. Distribution beyond these territories is prohibited; doing so risks account termination.
12. All shipping is via UPS Ground, unless otherwise requested. UPS cannot deliver to P.O. boxes. Distributors may request that shipment be made under their own courier account number, and Pinch will accommodate when possible.
13. We accept Visa, MasterCard, Discover, and American Express. All order will incur a $3.5 \%$ credit card processing fee. We regret that we cannot call ahead for credit cards; you must provide a credit card number when placing your order. Invoices marked paid are emailed upon shipping. A finance charge of $1.5 \%$ per month will be added to all past due accounts. If the need for collection arises, any collection fees will be paid by customer.
14. Color of kit and contents may vary slightly due to availability. Pinch Provisions must be notified of any damaged goods within 5 business days of delivery.
15. Products must be resold as-is, in their original packaging. The product, packaging, and digital images may not be altered in any way. Vendors may not add to or remove items from Pinch kits. We do not sell any empty or undecorated bags. Tampering with Pinch products in any way will not be tolerated; doing so risks account termination.
16. All distributors must provide their Tax ID number and are responsible for collecting state sales tax from their customers.
