READ AND SAVE THESE INSTRUCTIONS

Your Maxx Air fan is shipped fully assembled. Enjoy the powerful, cooling breeze that the fan will provide for virtually any indoor application. There are no additional spare parts shipped with this item.

SPECIFICATIONS: 110-120 Volt A/C polarized grounded plug with 11 foot supply cord. Do not remove grounding conductor from lug or use with an extension cord.

WARNING: To reduce the risk of fire or electric shock, do not use with any solid state speed control device. This fan motor is equipped with an automatic reset overload device. The fan may start unexpectedly. Do not put any object through the grilles into the blade or motor.

This fan is designed for indoor use only. Do not expose to the elements or allow to become wet. Do not use to exhaust hazardous chemicals or vapors. Unplug unit for storage, when not in use or moving locations.

MAINTENANCE OR SERVICE INSTRUCTIONS: Always unplug or disconnect the fan from the power supply before servicing. Remove grilles to clean with mild detergent, allow to dry, and reinstall as previously installed.




ESPECIFICACIONES: Enchufe polarizado y puesto a tierra de 120V~ corriente alterna, con cable alimentador de 11 pies (3,4 metros). No hay que quitar el conductor a tierra de la agarradera ni usar con un cable alargador.


ADVERTENCIA: Para reducir el riesgo de incendio o electrochoque, no hay que usar con ningún dispositivo de estado sólido para control de velocidad.

El motor de este ventilador está provisto de un dispositivo de reenganche en caso de sobrecarga. El ventilador puede arrancarse inesperadamente. No hay que introducir objetos que desenchufarlo antes de guardarlo, cuando no esté en uso o al moverlo a otra parte.

INSTRUCCIONES PARA MANTENIMENTO O SERVICIO: Siempre hay que desconectar el ventilador de la toma de corriente antes de hacerle un servicio. Hay que retirar las rejillas para limpiarlas con un detergente suave, dejarlas que se sequen y volver a instalar.

In the event of a defect or malfunction, we will replace or repair the defective part or component only and return the new or repaired part to you freight prepaid.

You must bear all other expenses incurred in obtaining repairs, including labor required for field repair or replacement, and the cost of shipping the defective part to us. You must also bear the cost of repair to or replacement of any part or component and the shipping charges incurred for the repair or replacement and return to you of any part or component not covered by this warranty, including parts or components damaged by you.

The company reserves the right to demand and receive written evidence of the date of purchase before undertaking its obligations under this warranty. The right to demand and receive written evidence of date of purchase extends to all licensed dealers of Ventamatic, Ltd. products.

You should, therefore, retain your sales slip and attach a copy of it to the warranty claim.
