The Satanic Temple has Launched Two Jingles in Support of their New Mexico Abortion Clinic
TST's Religious Reproductive Rights Campaign seeks to raise awareness for its new Samuel Alito's Mom's
Satanic Abortion Clinic.

SALEM, MA — The Satanic Temple's Religious Reproductive Rights Campaign (RRR) inaugurated their first-ever telehealth abortion clinic in New Mexico earlier this year. The Samuel Alito's Mom's Satanic Abortion Clinic (SAMSAC) provides free abortion services to anyone traveling to or residing in New Mexico.

"Our clinic was founded with the explicit goal of providing free reproductive care to anyone who needs it," noted TST's Executive Director Erin Helian. "The Samuel Alito's Mom's Satanic Abortion Clinic is a big first step toward that goal."

SAMSAC's location allows it to provide a vital service not only for the residents of New Mexico but also for neighboring states, namely Arizona, Utah, Texas, and Oklahoma, where abortions were restricted, if not outright banned, after the Supreme Court's ruling in *Dobbs v. Jackson Women's Health Organization*. However, it is TST's assertion, via multiple pending lawsuits, that the religious nature of their Abortion Ritual exempts the practice from otherwise applicable abortion restrictions. The Satanic Temple has also stated it has provided financial aid and travel accommodations for patients in need in the past and plans to expand those capabilities depending on its funding.

"Our two jingles serve dual purposes - to let people know about our clinic so that those who need it, or may need it in the future, know where to turn; and to bring wider attention to TST Health's ongoing Supreme Courtship fundraiser," added Helian.

The funds raised will be used to keep the clinic's operations free, maintain their 24/7 helpline and fully licensed staff, as well as support TST's legal efforts to protect religious reproductive rights and other efforts, according to The Satanic Temple. In addition, the amount raised will be one of the more important metrics the organization uses to determine its plans for future clinics in other states.
