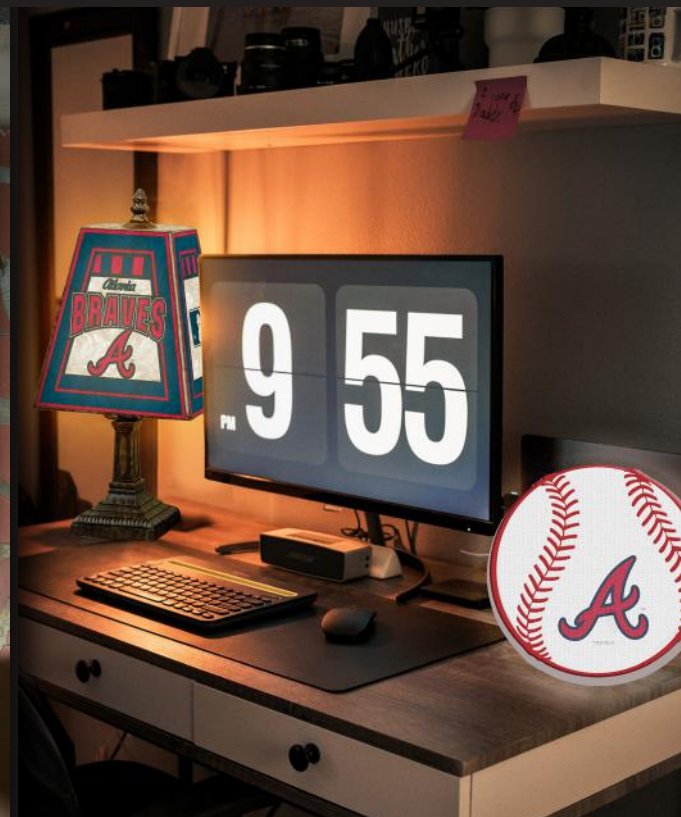

TERMS AND CONDITIONS:

NEW ACCOUNTS: A REQUEST TO OPEN A NEW ACCOUNT MUST BE ACCOMPANIED BY A TMC CREDIT APPLICATION AND TRADE REFERENCES OF CREDIT CARD INFORMATION. THE MEMORY COMPANY (TMC) MUST APPROVE OPENING AN ACCOUNT BEFORE AN ORDER CAN BE PROCESSED. ALL CREDIT APPLICATIONS AND ORDERS REQUIRE A SIGNATURE. **ORDERS:** OPENING ORDERS MUST MEET A \$500 MINIMUM AND MEET ALL TMC TERMS AND CONDITIONS. REORDERS UNDER \$100.00 WILL BE CHARGED A MINIMUM ORDER FEE OF \$10.00. **PRICES:** MERCHANDISE IS INVOICED AT THE PRICE PREVAILING AT THE TIME OF SHIPMENT AND IS SUBJECT TO CHANGE WITHOUT NOTICE. **UNIT MINIMUMS:** ALL ORDERS MUST BE PLACED IN CASE PACK MINIMUMS. ITEMS ORDERED UNDER CASE PACK MINIMUM ARE SUBJECT TO A \$2 CHARGE PER ITEM. **BACKORDERS:** ITEMS NOT AVAILABLE AT TIME OF SHIPMENT WILL BE BACKORDERED UNLESS SPECIFIED OTHERWISE. **TERMS:** NET 30 WITH APPROVED CREDIT, OR PAYMENT VIA MAJOR CREDIT CARD - VISA, MASTERCARD, DISCOVER, OR AMERICAN EXPRESS IS ACCEPTED. COD ORDERS CANNOT BE ACCEPTED. A SERVICE CHARGE OF 1.5% PER MONTH WILL BE CHARGED ON ALL PAST DUE INVOICES. **CANCELLATIONS:** ORDERS CAN BE CANCELLED UP TO 15 DAYS PRIOR TO REQUESTED SHIP DATE BUT NOT WITHIN 15 DAYS OF REQUESTED SHIP DATE. ALL CANCELLATIONS MUST BE IN WRITING AND FAXED TO 334-480-0197 OR E-MAILED TO CUSTOMER SERVICE AT ORDERS@MEMORYCOMPANY.COM. BACKORDERS CAN BE CANCELLED AT ANY TIME PRIOR TO BEING STAGED FOR SHIPMENT. **CLAIMS:** ALL CLAIMS FOR SHORTAGES, DAMAGES OR SHIPPING ERRORS MUST BE MADE TO TMC CUSTOMER SERVICE (CLAIMS@MEMORYCOMPANY.COM) WITHIN 15 DAYS OR ORDER RECEIPT - NO EXCEPTIONS. **RETURNS:** RETURN AUTHORIZATION IS REQUIRED. TMC MUST APPROVE ALL RETURNS IN ADVANCE. RETURNS WILL BE ACCEPTED FOR THE FOLLOWING REASONS: (1) DAMAGED OR DEFECTIVE MERCHANDISE (2) OVER SHIPMENT OF SHIPMENT ERRORS. A 15% RESTOCKING FEE APPLIES TO ALL OTHER RETURNED ORDERS, INCLUDING REFUSED ORDERS. RETURN SHIPPING TO TMC IS AT THE EXPENSE OF THE CUSTOMER.
