

# PIGNX BIO-REPELLENT BIRD GEL



I just wanted to give you a little update on what we have seen recently with the use of PIGNX. We have applied it in several different scenarios now and even in areas where we have used products like “hotfoot” in the past. PIGNX has repeatedly had a superior ability to repel birds and not just from the areas we apply it, but also from the entire building it is on. From what I have observed in the change of the bird’s behavior this ability to repel from a treated building has to be a result of the capsaicin in your product. It is obvious that this biological reaction to the product in comparison to the bird’s reaction to polybutene products is just like a flock’s reaction to noise deterrents vs. methyl anthranilate. The results are much more long term and the behavior is changed not just where the product is applied but in an invisible sphere around the area. I would love to see some research done on just how far these birds are being driven away

Your product went above and beyond my expectations. We had a problem with sparrows that was getting out of control. The challenge was that we have a huge facility approximately 200,000 sq. ft. and the ceiling is 60ft high. My company wanted a 100% solution that was non-toxic since we are a food distribution company. We also comply with NSF and FDA standards. I had Orkin Bird Control come out and do a proposal on what it would take to stop this problem. I was looking for a solution that wasn't toxic and worked well with our budget.
