energy conservation

Over the past few years, we have invested in new technology to meet our own tough standards and ambitious goal of energy conservation and waste reduction. We reduced natural gas consumption by 40%, electricity usage by 10%, and in-process waste by 15%. Those investments, among others, have made significant and permanent reductions to our environmental footprint.

## indoor air quality certification

We reformulated our commercial vinyl wallcovering to meet California Department of Health Services section 01350 indoor air quality requirements for office and school interiors.

## water-based inks

We developed smoke free, low V.O.C., water-based ink and coating systems that eliminate the need for air pollution controls. So for more than a decade, we have generated zero hazardous waste from our manufacturing processes!

## no lead or cadmium

Our contract vinyl does not use lead or cadmium in the pigments or substrates. And for those who wish to use a substitute product, we have paper substrates, produced from cellulose fiber, permeable non-woven materials, plus natural materials like grasses, sisals, and corks.
