- 1. Eligibility. The Will YOOBI My Valentine? Sweepstakes (the "Sweepstakes") is open only to individuals who are legal residents and physically located in one (1) of the fifty (50) states in the United States or the District of Columbia and who are at least thirteen (13) years of age or older at the time of entry. Employees, officers and directors of Yoobi, LLC ("Sponsor"), its parent, and each of their respective affiliates, subsidiaries, advertising and promotion agencies, distributors and other prize suppliers (collectively, the "Sweepstakes Entities"), and each of such employees', officers' and directors' immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to enter the Sweepstakes or win a prize. - **3.** <u>How to Enter</u>. There are three (3) methods of entry for this Sweepstakes:

The Website will contain a description of the Sweepstakes and a sign-up to receive emails from Sponsor. Each entrant who signs up to receive marketing emails from Sponsor during the Entry Period will automatically be entered into the Sweepstake drawing. Entrant must complete and submit the sign-up form with all required information (including a valid email address) for the entry to be eligible.
 - (ii) Facebook Application Entry. To participate and enter this Sweepstakes, individuals will need a Facebook account ("Account"). If you don't already have an Account, visit www.facebook.com to create an Account; creating an Account is free. By submitting your information and creating an Account, you will be required to agree to the Facebook's Statement of Rights and Responsibilities and Data Use Policy. If you do not agree to Facebook's terms

and privacy policy, you cannot create an Account or participate in this Sweepstakes. Once logged into your Account, to enter the Sweepstakes, during the Entry Period, visit the Yoobi Facebook Page at www.Facebook.com/Yoobi (the "Page"). Next, "like" the Page (if you have not previously "liked" the Page) and click on the Sweepstakes ad on the Page and entrants can then enter the Sweepstakes through the application (the "Application") that interacts with the Page by giving permission to the Application to collect entrant's information from entrant's Facebook profile. The Application will contain a description of the Sweepstakes and the official entry form. Each entrant will be asked to submit an official entry form, which may include, among other things, his/her full name, address (no P.O. Boxes), email address, gender, date of birth and related registration information as prompted. Entrant must complete and submit the entry form with all required information for the entry to be eligible.

(iii) Mail-In Entry. Each mail-in entry must be submitted to Sponsor at the address above in a separate envelope (or item of mail). All mail-in entries must be postmarked by February 4, 2014 and received no later than February 16, 2016 to be eligible for the Sweepstakes.

Limit of six (6) entry/entries per person during the Entry Period (regardless of method) will be accepted. During the Sweepstakes Period, each participant is limited to receive one (1) entry through the Sweepstakes entry section of the Website and five (5) additional entries based on the sharing completion of specific activities (such as sharing specified content), as detailed on the Website. Each individual is limited to one (1) Application per person. Registered account holder is defined as the person assigned to an email address by an Internet access provider, on-line service provider or other organization responsible for assigning email addresses. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. For purposes of this Sweepstakes, an on-line entry is "received" when the Website's or Application's (as applicable) servers record the entry information. Proof of sending (such as an automated computer receipt confirming entry or "thanks for entering" message) does not constitute proof of actual receipt of an entry for purposes of this Sweepstakes. The Website's database clock will be the official timekeeper for this Sweepstakes. Illegible and/or incomplete entries and entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. Sponsor may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) campaign, contest or sweepstakes does not constitute entry into any other. Minor entrants must obtain their parent or legal guardian's permission prior to entering.

4. Winner Selection and Prize Claiming. There will be three (3) winners selected in this Sweepstakes. The potential winners will be selected through a random drawing on or about February 17, 2016 from all eligible entries received in accordance with these Official Rules. Sponsor will have complete discretion over interpretation of the Official Rules, of administration of the Sweepstakes, and of selection of the winners. Decisions of the Sponsor as to the selection of the winners will be final. The potential winners will be notified using the information provided during entry by any of email and/or telephone and/or mail (as selected by Sponsor) in a commercially reasonable time after the drawing. The Sweepstakes Entities are not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email, placing of a phone call, one (1) day after sending via a delivery service or two (2) days after mailing. A potential prize winner who provides a P.O. Box may be required to provide an alternative address and this may cause a delay in notification and acceptance so use of a P.O. Box is discouraged. Sponsor reserves the right to change the specific Yoobi products included in each prize package in Sponsor's sole discretion. Prizes are non-transferable, with no cash redemptions, equivalents or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and prize provider's rules and restrictions, and in the event that Sponsor is unable to provide a winner with his or her prizes, the Sponsor may elect to provide winners with the approximate value of such item in cash or award an alternate prize of comparable or greater value. The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.

- 11. Entry Information and Sweepstakes Communications. - 12. Governing Law / Limitation of Liability. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of California, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.

13. <u>Dispute Resolution</u>. The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in Los Angeles County, California and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Los Angeles County, California. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
