### 3. Operation

#### 3.1 Transport Mode

Sensors are shipped with a plastic battery insulating pull tab that must be removed before the operation.

#### **3.2 Default Operation**

During default operation, the device will send a message to the network once there is a sufficient delta in the environmental conditions or after 60 minutes of inactivity. The precise trigger values can be found in 4.1.1.

### 5. Battery

#### 5.1 Replacement

Use ER14250 or equivalent. Remove the upper cap and replace the battery.




