Name of Product: Bicycles

An open quick release lever on the bicycle's front wheel hub can come into contact with the front disc brake assembly, causing the front wheel to come to a sudden stop or separate from the bicycle, posing a risk of injury to the rider

Remedy: Repair

Consumers should stop using the recalled bicycles immediately and contact an authorized Rocky Mountain retailer for free installation of a new quick release on the front wheel

RECALL DETAILS

Units: About 17,000 (in addition, 61,000 were sold in Canada)

Description: This recall involves all 2003 through 2016 models years of Rocky Mountain bicycles equipped with front disc brakes and a black or silver quick-release (QR) lever on the front wheel hub. Bicycles that do not have disc brakes are not included in this recall. When the front QR is fully opened, if there is less than 6 mm -- or the width of a #2 pencil -- between the QR and disk brake rotor on the wheel, the bicycle is included in this recall

Incidents/Injuries: None reported.

Sold at: Rocky Mountain bicycle dealers nationwide and online at Eastern Mountain Sports, Jenson US, Mike's Bikes, Performance Bike Shop and Rocky Mountain Cyclery from January 2003 through April 2016 from between \$250 and \$15,000

Manufactured in: Canada, China, Taiwan and Vietnam




