

Mr Vitamins Ultimate Getaway Competition

Terms and Conditions

Your entry into Mr Vitamins Ultimate Getaway Competition (**the Competition**) is deemed acceptance of the following Terms and Conditions. Information on how to enter the Competition and the Prize(s) form part of these Terms and Conditions.

Who Can Enter

1. The Competition is open to residents of NSW, Victoria, South Australia, ACT and Queensland aged 18 years and over.
2. Employees and immediate families of Mr Vitamins (**the Promoter**) and associated agencies are not eligible to enter the Competition. Immediate family includes: spouse, ex-spouse, defacto spouse, child or step-child (including by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

6. Unless otherwise stated in these Terms and Conditions, you are not required to purchase any goods or products from the Promoter in order to enter the Competition. Purchasing goods or products will not increase your chances of winning.

How to Enter

7. The Competition commences on 04/10/2023 at 09:00 and closes on 10/11/2023 at 23:59 (**the Competition Period**).
8. Entries must be received within the Competition Period.

The Prize
