- If your skin is not dry within 1 minute, dab off excess with a tissue.
- A light, oil-free and fragrance-free moisturizer may be applied if desired.
- If you are going outdoors during daylight hours we highly recommend that you use a high qualitybroad spectrum sunscreen of SPF20 or higher.
