# DESCRIPTION

A durable gloss – high solids pure thermoplastic floor finish with anti-slip traction texture. This pure acrylic floor finish is produced in high pressure reactors using proprietary molecularly engineered polymers, the finest high pressure micronized wax emulsion, preservatives, leveling aids, interacted plasticizers and deionized water to offer a premium grade floor finish.

### **DIRECTIONS FOR USE**

A premium quality high solids floor finish that provides a durable gloss in four applications with a slip resistant texture. Durable, detergent resistant, easy application, non-scuff, non-black marking and metal bonded for outstanding wear and appearance with a minimum of maintenance. Recommended for all floors.

**Application of Finish:** For best results seal terrazzo, concrete, cork and porous resilient tile floors before application of finish. Apply a thin uniform coat of finish in the conventional manner. Allow to dry for a minimum of 30 minutes after each coat. Do not apply more than four coats in a 24-hour period. Be sure to apply the anti-slip texture uniformly across the surface. Allow finish to thoroughly dry before allowing traffic on the floor. Provides outstanding beauty and gloss on sealed floors. If floor is unsealed or highly porous, additional coats may be required on the initial application. Please note this product is for vinyl, vinyl like surfaces, most stone surfaces, terrazzo. This product is not to be used on ceramic, porcelain, rubber or wood.

**Maintenance:** Maintain in the conventional manner by cleaning with a treated yarn dust mop to remove surface dirt daily. Damp mop or clean with an automatic scrubber as required, using an approved neutral cleaner at the specified dilution. Spray buffing to remove embedded soils is recommended. Worn areas, or the entire floor, may be re-coated as required to maintain a uniform high gloss. When stripping becomes necessary use an approved stripper for detergent resistant finishes.
