I assume all risks regarding and I commit to adhering to any legal and safety and policy protocols. I hereby waive and release, for myself and for my heirs and assigns, any and all claims, causes of action, or liabilities which may hereafter accrue against Samovar Gardens LLC DBA Piper and Leaf Tea Co and The Vision Camp, and its affiliates, their agents, employees, volunteers, officers, directors, successors and assigns, the City of Huntsville, Madison County, and any and all sponsors, their representatives and successors, that may arise as a result of my participation in Piper and Leaf or The Vision Camp events or venues, including any and all claims for personal injuries caused by Piper and Leaf Tea Co or The Vision Camp negligence or unforeseen hazards or failure to comply with policies. In the event that undersigned fails to pay for actual damages caused and billed for, interest shall accrue upon the unpaid balance at the rate of 8% per year until it is paid. Undersigned shall also be liable to owner for any legal fees, court costs, and other expenses associated with collection. Undersigned will be liable for any physical damages, legal actions, and/or loss of reputation or business opportunities that Owner may incur as a consequence of the actions of Undersigned or any of Undersigned's guests while Undersigned is in control of the venue, and shall indemnify and hold harmless the Owner against any and all legal actions which may arise from Undersigned's use of the venue. Any disputes arising under this contract shall be adjudicated in the Owner's local jurisdiction.
