### **Product Description**

The Enclosures are intended for residential and commercial use. The Cezanne, Luna, Pacific & Compass are sliding door enclosures. (Pacific & Compass are also available in Square Pivoting Door enclosures, please refer to the separate BPIR for these). They are manufactured from Pre-finished extruded Aluminium sections and grade A safety glass.

Available in:

- Square : (Cezanne & Luna only) : 900x900mm, 1000x1000mm 2 sided and Alcove installations.
- Rectangular: (Cezanne & Luna only) : 900x1000mm & 1200x900 2 Sided and Alcove installations.
- Round : 900x900mm, 1000x1000mm & 1200x800mm (Cezanne & Luna only)
- Heights: 1920mm
- Colour: Cezanne & Luna White & Bright Anodised

• Doors: Cezanne & Luna - 6mm grade A Safety glass.

Pacific & Compass - 6mm Door & 5 mm Take up grades A safety glass

#### Scope of Use

The Sliding shower door sets are designed for internal use only. They are suitable for residential and commercial installations. They are designed to be installed on Clearlite shower trays but may be used with other trays of similar specifications or on tiled floors.

#### **Conditions of Use**

- If the Sliding Door set is to be installed on a Clearlite shower tray with tiled walls the Door set must be installed directly to the water proof membrane to ensure fitment within the tray's upstands.
- Only the Adhesives & Sealants supplied by the manufacturer must be used in the installation
- Any Plumbing must be carried out by a certified Plumber
