Product Description

Clearlite Drop in Baths are suitable for residential and commercial applications. They are manufactured from thermoformed Sanitary grade Acrylic and reinforced with a fibreglass sandwich laminate. Available only in white

Pacific: 1655x740mm & 1525x740mm

Matisse: 1655x740mm

Kahlo: 1675x750mm & 1800x800mm
Varo: 1675x750mm & 1800x800mm

Features

- The Pacific, Matisse and Dina baths feature a fully moulded 20mm tall upstand.
- The Kahlo & Varo baths can have optional factory fitted 15mm powder coated aluminium upstands
- Drainage to the waste will be no less than a 1:50 gradient
- All baths except the Dina are available with an optional timber support frame
- Baths can be used as Shower over bath when an optional acrylic wall liner, Bath panel or enclosure is specified

Scope of Use

- Clearlite drop in baths are for internal installations only.
- They are suitable for residential and commercial applications

Conditions of Use

- The bath's top perimeter flange must be installed level to ensure drainage.
- The bath's top perimeter and floor must be supported to prevent any deflection
- For safety reasons hot water temperature must be limited to 55 ° C
- Any Plumbing must be carried out by a certified Plumber
