The Trombone Pivot Shower Door and Bath enclosure is intended for residential and commercial use. The Shower Door sets are adjustable in width to suit varying shower door frame openings. They are suitable for Alcove installations but can be paired with a Clearlite Return Panel for two side applications if required. The Trombone bath enclosure is designed to fit Clearlite Pacific & Matisse baths. They are manufactured from Pre-finished extruded Aluminium and grade A safety glass.
