






INTRODUCTION

INSTRUCTIONS



Open the box and place inside the items to be sterilized.




Close the lid. Press and hold o until the indicator light switches on. Your UVC LED sterilizer is now ready for use.





Do not overlap items. Do not overload the sterilizer box and ensure that the sterilizer box can be closed properly.



- Press $oldsymbol{\psi}$ to begin the sterilization process. During sterilization, the indicator light on your box will flash continuously.
- After 3 minutes, the sterilization process is complete and the device will automatically switch to standby mode. The indicator light will stop flashing and change to solid.
- 6 Open the lid and remove sterilized items.
- 7 The device will automatically enter sleep mode after 5 minutes.



Do not open the lid during sterilization. As a safety measure, the device will automatically turn off when lid is open.

BACTERICIDAL PROPERTIES OF UVC LED TECHNOLOGY

When used correctly, this UVC LED Sterilizer is an effective bactericide that can inactivate bacteria such as Escherichia coli & Staphylococcus aureus. During sterilization, items placed at a distance of 3.7 cm or less from the LEDs will achieve a UV light intensity between 105 to 2154 $\mu\text{W/cm}^2$, killing 99.9% of microorganisms.

HISTORY OF PHOTOTHERAPHY

Niels Ryberg Finsen (15 December 1860 - 24 September 1904) was a Danish-Faroese physician and scientist. He is the first Nobel laureate from the country and the founder of modern phototherapy. Dr Finsen, received the 1903 Nobel Prize in Physiology for the application of light in medicine.

Diagnosed with Niemann-Pick disease, his condition served as a catalyst to further explore the scientific benefits of light. By 1893, Dr Finsen's research of light lead to the foundation of modern phototherapy. His laboratory work and subsequent clinical experiments successfully showed that rays of light such as red light and Ultraviolet (UV) rays were effective in treating smallpox and lupus vulgaris respectively.

A. WARRANTY
