



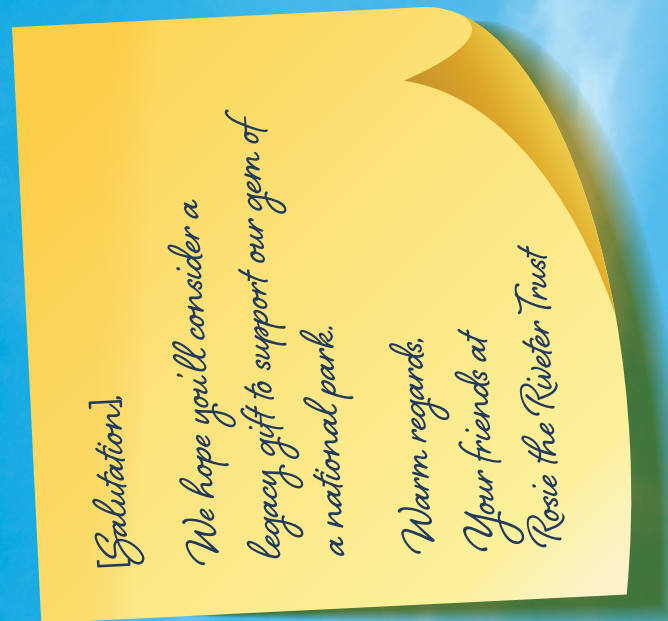
How has the WWII home front history inspired you?

Simple Steps to Leaving a Legacy

Arranging a legacy gift helps ensure that the spirit and determination of Rosie the Riveters and all the home front workers will help fire the imaginations and community spirit of current and future generations. Legacy gifts can be simple to set up and some even return life income to you. Below are the most common forms of legacy gifts. **Might one or more of these help you fulfill your vision and financial plans?**

Specify a Bequest in Your Will or Revocable Living Trust

You can leave a specific amount, a percentage of your estate, or what remains after bequests to your loved ones have been fulfilled. Bequests cost you nothing now, and you can change your mind later if you wish.

Retirement Funds Beneficiary

Naming Rosie the Riveter Trust as a beneficiary of your retirement funds, life insurance policies, bank accounts, or donor-advised funds can be arranged by contacting your plan administrator to name *Rosie the Riveter Trust* as the beneficiary.

Because retirement funds may be heavily taxed when inherited by individuals, you might consider leaving retirement funds to charity and directing other assets to family.

Charitable Gift Annuity

A Charitable Gift Annuity pays you a fixed annual income based on your age for the remainder of your lifetime, beginning now or deferred until a later date. Charitable Gift Annuities are set up through a simple contract. Rosie the Riveter Trust partners with the Silicon Valley Community Foundation (SVCF) to issue charitable gift annuities at amounts of \$25,000 or more.

Charitable Remainder Trusts

This gift is established with the help of an estate planning attorney. This type of trust can benefit you, your heirs, and charity as well. A Charitable Remainder Trust pays you income for life (or a specified number of years) based on investment returns and, after your lifetime, the remainder is given to Rosie the Riveter Trust.
