



One Year Limited Manufacturer's Warranty

Pierco Inc. warrants this product to the original retail purchaser to be free of material and/or workmanship defects for a period of one year after the date of original retail purchase. Proof of the original purchase is required to obtain a remedy under this limited warranty and the product must be returned to Pierco at your expense.

During the limited warranty period, Pierco or its authorized service representative will repair or replace at Pierco's option, without charge, a materially defective product. We may use new or refurbished replacement parts. If we replace the product, it may be with a new or refurbished product of same or similar design. Pierco may keep any removed or defective parts, and/or replaced product. The repaired or replaced product is warranted for the remainder of the original warranty or 90 days, whichever is greater. Repair or replacement of this product at Pierco's option is your exclusive remedy.

This limited warranty only applies to products purchased, used and serviced in the United States and its territories. If you purchased this product outside of the United States, its territories or Puerto Rico, contact your dealer for service information.

This is the only warranty applicable to this product.
