
**NOTICE:** Green ground wire is provided in proper location. Do not relocate.





- 1. When the luminaire is switched on, there is a 15 second initialization period where the light will flash on and off, and then dim. It will remain dimmed for the current Stand-By Time, or until motion is detected.
- 2. When the settings are changed, the luminaire will flash on and then turn off. It will remain off until motion is detected.




# WIRING DIAGRAMS




# **SENSOR MOUNTING**



# SENSOR COVERAGE



# **NOTES:**

Be cautious if installing this sensor in areas with a large presence of metal (such as walls or machinery). Microwaves can reflect off metal surfaces and can potentially lead to false detection of movement.


In order to test the Sensitivity level, keep the Hold Time and Stand-By Time low so that the full cycle can quickly be observed. Once the sensitivity is confirmed through testing, the Hold Time and Stand-By time can be set to the desired levels.

It is recommended to start on a lower Sensitivity setting and increase as needed. Microwaves can pass through most non-metal materials (including drywall and wood) and could detect motion on the other side of walls if the sensitivity is set too high.

For indoor applications the Daylight Sensor is typically not used and should be disabled.



### **SENSITIVITY**

The sensitivity setting will adjust the detection range to a maximum radius of 17 ft.




### **HOLD TIME**

The Hold Time is the first stage of the motion cycle. This is the amount of time that the fixture will remain at 100% brightness. If no motion is detected during this period, the luminaire will dim to the Stand-By Dim setting. If motion is detected, this time will reset.



### STAND-BY DIM


Once the Hold Time has expired and there is no motion, the luminaire will dim to the Stand-By Dim level. It will remain at this level for the duration of the Stand-By Time setting, providing no motion is detected.

### **STAND-BY TIME**

The Stand-By Time is the amount of time that the luminaire will remain at the Stand-By Dim level before turning off, providing no motion is detected. If motion is detected, the luminaire will go back to 100% and the hold time will reset. When the +∞ setting is selected then the luminaire will remain at the Stand-By Dim level indefinitely, and the fixture will not turn off.
