

Description:

VIVO™ is a dietary supplement that uniquely enhances female sexual health*. What is DHEA?:

DHEA is a natural hormone, made in the body by all women and men. DHEA is an intermediate step in a complex process called steroidogenesis, in which cholesterol is converted into testosterone and estradiol. DHEA levels decline significantly with age.

Potential Benefits:

DHEA has been shown to enhance sexual health in younger, premenopausal women after 4-6 weeks of supplementation*.

Safety:

DHEA is widely considered safe for most people if used at moderate dosages of up to 100 mg daily, and for limited times.

- VIVO™ is not intended for individuals under the age of 18, and should not be taken by individuals with known hypersensitivity to any of its ingredients.
- Women with estrogen-sensitive benign medical conditions (e.g., endometriosis) or polycystic ovarian syndrome (PCOS) should not take VIVO™ without prior medical consultation and clearance
- Like many supplements, DHEA may interact with other medications. Women who receive medical treatments and/or drug therapies should not take VIVO™ without prior medical consultation with and clearance from their healthcare provider.
- Diabetic patients may experience changes in insulin requirements when supplementing with DHEA and should not initiate VIVO™ supplementation without prior clearance from their healthcare provider. Once supplementing with

- VIVO™, glucose levels should be monitored with increased vigilance.
- Individuals with a history of mood disorders have experienced mania, irritability and sexual inappropriateness while supplementing with DHEA. Individuals with mood disorders should not initiate VIVO™ supplementation without prior clearance from, and, once supplementing with VIVO™, should report any changes in mood to, their mental healthcare provider.
- DHEA has been reported to lower high lipoprotein cholesterol (HDL), the so-called "good cholesterol," Individuals with a history or family history of lipid abnormalities should not take VIVO™ without prior clearance from their healthcare provider. Careful monitoring of lipid levels is recommended for those who take VIVO™ as a supplement on a regular basis.
- DHEA may make liver problems worse. If you have existing liver conditions, consult your healthcare provider before initiating supplementation with VIVO™.

- NOT FOR USE BY WOMEN WHO ARE UNDER THE AGE OF 18.
 DO NOT USE IF PREGNANT OR NURSING.
 - Consult a physician or licensed qualified healthcare professional before using this product if you have, or have a family history of, heart disease, low "good" cholesterol (HDL), or if you are using any other dietary supplement, prescription drug, or over-the-counter drug. Do not exceed recommended serving. Exceeding recommended serving may cause serious adverse health effects. Potential Side Effects:

Reported side effects of DHEA supplementation include: oily skin, acne, hair loss, increased hirsutism (hair growth), deepening of the voice, increased libido and assertiveness, gastrointestinal complaints and hypertension.

Should supplementation with VIVO™ lead to unwanted sideeffects, discontinue supplementation or consult with a healthcare provider immediately. To report any adverse effects associated with VIVO™ call 212-628-0851.

How Supplied:

VIVO™ is uniquely packaged in individual blister sheets, each containing one week's supply of 21 tablets in a 3 (daily 25 mg tablets) by 7 (days in the week) layout. Each box contains 4 sheets (84 tablets), a four-week supply.

Storage:


VIVO^{ms} should be stored at room temperature (15°-30°C/59°-86°F). Excessive heat exposure should be avoided.
