This job description sets out the scope of the role of the **Stock Control Assistant** with the main duties of the position at the date when it was completed. It does not include or define all responsibilities or duties which the post holder may be expected to carry out. Duties may vary from time to time without changing the nature of the post or the level of responsibility. The post holder may also be required to carry out any other duties to co-operate with the general work of the organisation, as required by their line or department manager.

Overview / Purpose of the Role

A permanent full-time vacancy for a Stock Controller has arisen within our Ballina Wholesale Operations division. Reporting to the UD Ballina Depot Manager, the overall purpose of the position is to manage UD Ballina Stock Control in carrying out day-to-day operations. Hours of work will be 37.5 hours between the core hours of 08:30am – 16:30pm. Work outside these hours will be required on occasion.

Key Responsibilities

- (Note this list is not a definitive list and there will be other duties required as part of a normal stock control team including working in other Business Units as required.)
- Engage in all UD Ballina stock control activities which include but not limited to:
- Make sure that stock accuracy is maintained throughout the warehouse.
- Assist in the preparation and the carrying out of stock takes and cycle counts when required.
- Liaise with customer services, Account Managers, Brand Managers warehouse supervisors/team leads, sales and other members of staff across the Group as required.
- Keep accurate KPI information and inform relevant parties.
- Ensure rotation of stock on a FEFO basis/ shortest dated stock supplied first.
- Investigate and close queries.
- Maintain Daily Housekeeping standards.
- Adhere to all SOP's and GDP's associated with area procedures.
- Cultivate a good working relationship with other departments.
- Actively Support ongoing Business changes

- Previous Warehouse/Operational experience desirable.
- At least 1 years' experience within operational stock control would be an advantage.



- 3 years' experience working with MS Office particularly Microsoft excel to a high level.
- Power BI experience would be an advantage.
