E-BIKE TEST WAIVER INDEMNITY AND RELEASE FROM LIABILITY

A PARTICIPANT TAKING PART IN A TEST DRIVE OF AN E-BIKE AGREES TO VOLUNTARILY ASSUME THE RISKS INVOLVED. BY SIGNING THIS RELEASE I RECOGNIZE THAT I AM GIVING UP THE RIGHT TO INITIATE ANY LEGAL PROCEEDINGS AGAINST EAST LAKE RENTALS INC.

I AGREE NOT TO SUE AND I FURTHER AGREE TO INDEMNIFY AND SAVE HARMLESS THE RELEASES FROM ALL EXPENSES, FEES, LIABILITY OR DAMAGE AWARD OR COST OF ANY TYPE WHATSOEVER ARISING FROM MY PARTICIPATION IN THIS TEST DRIVE.

Whereas the individual named below, (hereinafter referred to as the "participant") desires to take part in a test drive of an electric assist bike. And whereas EAST LAKE RENTALS INC. and its Authorized Dealers and operators are unwilling to allow the participant to do so, unless the participant and his/ her parent, if less than 19 years of age, agree to assume full responsibility for any loss, injury or damage which the participant might sustain while participating. Participants wishing to test drive an electric bike, must wear a protective bicycle helmet, must be 16 or older and be tall enough that their feet can reach the ground while sitting on the e-bike.

Witnessed that in consideration of other good and valuable consideration and covenants herein contained: the participant and his/her parent, if less than 19 years of age, covenant and agree;

1. ASSUME ANY AND ALL RISKS INVOLVED IN OR ARISING FROM PARTICIPANT'S TEST DRIVE OF THE E- BIKE, including, without limitation, the risks of death, bodily injury or property damage resulting from collision between the vehicle that he or she is riding and another vehicle, a person or stationary object; skidding; overturning; sudden stops; braking or acceleration; the unavailability of emergency medical care; or the negligent or deliberate acts of another person;
2. RELEASE EAST LAKE RENTALS INC .. and all its successors, assigns, subsidiaries, branches, operators, Authorized Dealers, affiliates, officers, directors, employees, and agents, and even landlords from, and not to sue them on account of or in connection with any claims, causes of action, injuries, damages, costs or expenses arising out of PARTICIPANT'S E-bike test drive, including without limitation, those based on death, bodily injury, or property damage, whether or not caused by the negligence or other fault of OPERATOR, including strict product liability or any other liability without fault;
3. The terms hereof shall be binding upon the participant and their parents, if under 19 years of age, notwithstanding that the death or injury, damage or loss to the participant or caused by the participant may have been caused or contributed to by negligence of the operators.
4. PAY for any and all damages to ELECTRIC BIKES caused by PARTICIPANT, negligently, wilfully or otherwise; and AGREE that by taking part in a test drive of an E-bike owned by EASTLAKE RENTALS INC. or its Authorized Dealers, I acknowledge that I am cognizant of all the inherent dangers of driving an E-bike offered to PARTICIPANT and the basic safety rules for driving such vehicles (and if not I will advise OPERATOR and request further assistance so that I may fully understand them).
5. I agree that I, the PARTICIPANT, will not participate in any test drive if under the influence of drugs or alcohol, if pregnant, or if there is any other physical condition that may impair the ability to understand instructions or to participate without creating risk to others or myself.

I HAVE READ THIS AGREEMENT. I UNDERSTAND THAT BY MAKING THIS AGREEMENT I SURRENDER VALUABLE RIGHTS. I DO SO FREELY AND VOLUNTARILY. I FURTHER CERTIFY THAT I AM OF LAWFUL AGE, AND LEGALLY COMPETENT TO SIGN THIS AGREEMENT; THAT I UNDERSTAND THAT THE HEREIN ARE CONTRACTUAL AND NOT A MERE RECITAL; THAT I HAVE SIGNED THIS AGREEMENT AS MY OWN FREE ACT AND IF I HAVE ANY DOUBTS CONCERNING THE CONTENTS OF THIS AGREEMENT, I WILL CONSULT AN ATTORNEY BEFORE SIGNING IT.
