No split cases. **Minimum Order Quantity and Prices:** refer to the most current Wholesale Price List for minimum order quantities and prices which are subject to change at anytime. **Orders:** must be sent to [info@globalteas.co](mailto:info@globalteas.co), placed online thorough the wholesale portal on Seller’s website or by phone. **Payment:** ACH money funds bank transfer (preferred), certain credit cards (3% fee), or check is acceptable. Shipment occurs after payment is received and bank cleared, unless otherwise negotiated. Terms can be offered on a case by case basis to longstanding customers. Accounts over 30 days may be suspended and charged 5% monthly. **Shipping:** orders usually ship within 2-5 business days upon payment in full. Report exterior carton damaged within 24 hours. Buyer is responsible for all shipping costs and for selecting a shipping method when placing orders thorough the wholesale portal on Seller’s website, by email or by phone. **Returns/defect:** Damage to product or shipping error must be reported to Global Teas, LLC within 7 days of delivered receipt.
