COUNTY-BY-COUNTY ALLOCATION ESTIMATES

In a major victory for America's counties, Congress passed and President Biden signed the State and Local Coronavirus Fiscal Recovery Funds legislation, part of the American Rescue Plan Act. **The bill includes \$65.1 billion in direct, flexible aid to every county in America, as well as other crucial investments in local communities, including \$1.5 billion over two years for public lands counties.**

The U.S. Department of the Treasury would oversee and administer these payments to state and local governments, and every county would be eligible to receive a direct allocation from Treasury. Municipalities and counties would now receive funds in two tranches – with 50 percent this year and the remaining 50 percent no earlier than 12 months from the first payment. **The U.S. Treasury is required to pay first tranche to counties not later than 60-days after enactment, and second payment no earlier than 12 months after the first payment.**

The table below contains projected allocations for counties from the U.S. Treasury, if the proposal is signed into law. The values are informed by the House of Representatives and the Congressional Research Service (CRS). **The estimates are not official values from the U.S. Treasury and are subject to change.**

NACo will be working closely with Treasury to guide and inform the implementation of this historic legislation as intergovernmental partners.
