OPERATING & CHARGING PROCEDURE

Operating Instructions

- Press the ON/OFF Switch once: Spotlight will activate.
- Press the ON/OFF Switch twice: Flood Light 'ECO Mode' will activate.
- Press the ON/OFF Switch a third time: Flood Light 'Normal Mode' will activate.
- Press the ON/OFF Switch a fourth time: Flood Light 'Full Power Mode will activate.
- Press ON/OFF Switch a fifth time: Mini Camp Light will turn off.
- Battery Level Indicator provides at a glance battery status via 3 LEDs.

Charging

- Switch lamp off during charging.
- Whilst charging the LED indicator will flash green.
- When charging is complete, the LED will illuminate solid green.

NOTE

- Only use the supplied charging cable when charging the Mini Camp Light. The use of a NON-recommended charging cable can lead to malfunction of the Mini Camp Light or thermal incident.
- We recommend charging the Mini Camp Light for 4-5 hours before first use.
- Fully charge the Mini Camp Light before it is stored for a long periods.

SAFETY INSTRUCTION

- Do not use the device if there is damage to the housing, plug or cable. Consult your local authorised specialist!
- Do not open the device! Repair work and replacing the rechargeable battery pack may only be carried out by an authorised specialist.
- Carry out cleaning tasks only when the mains plug is removed from the mains power!
- There is a risk of short-circuit. Repairs on the device may only be carried out by commissioned and trained persons. Please contact your nearest authorised specialist.
- Protect the battery against heat, eg. against continuous intense sunlight, fire, water, and moisture. Danger of explosion.
- If the battery is damaged or not used correctly, fluids can leak from the battery. Avoid contact with these. Leaking battery fluids can lead to skin irritation or burns. Rinse off with water if you should come into contact. If the fluid gets into your eyes, seek medical help.


