

# Lithofin P&L Shine Protector for Parquet and Laminate

#### Description

A special product from the LITHOFIN-Range for parquet, laminate, cork, linoleum and other synthetic floors (P&L). Protects and enhances the surface with a natural sheen film.

# **Properties**

Lithofin P&LShine Protector protects against scratches and stains, prevents the surface from becoming matt and enhances the appearance through a natural sheen.

### Field of Use

For protecting sealed parquet, laminate and cork floors against scratches, dirt accumulation, wear and tear and for facilitating regular maintenance. This protective treatment is highly recommended on newly laid surfaces, but is also suitable for restoring the appearance of used floors.

## **Directions for Use**

First, the surface must be thoroughly cleaned with Lithofin P&L Basic Cleaner. Allow the surface to dry completely.

Before applying Lithofin P&L Shine Protector, shake the bottle well. Thinly and evenly apply the product undiluted with a cotton cloth working towards the joints. The product will be dry in approx. 60 minutes, fully hardened and effective withing 24 hours. Lithofin P&L Shine Protector can be applied several times in order to achieve a higher degree of sheen.

<u>Please Note:</u> do not use on warm surfaces. Turn down or switch off under floor heating. Please observe the treatment advice provided by the manufacturer of the floor material.

Coverage: approx. 30 to 40m² per litre.

#### Storage

Closed, cool and dry. Up to 2 years.

## **Environmental Protection**

Does not contain any phosphates. The contained surfactants are biodegradable according to regulation (EC) No. 648/2004 (detergents regulation). Disposal: waste code according to EWC/AVV 07 01 99. Bottles/canisters are mode of environmentally friendly polyethylene and can be recycled (see information on label).
