

Lithofin Composite Cleaner for quartz composite

Description

A special product from the LITHOFIN-Range for quartz composite and similar artificial stones. This solvent based cleaner dissolves and removes a wide range of dirt deposits.

Properties

Lithofin Composite Cleaner dissolves and removes oil, grease, residues of wax, stickers, pen and other stubborn marks. The residues are dissolved and can then be easily washed off with water.

Field of Use

For deep cleaning all polished, honed or brushed quartz composite surfaces. Also suitable for natural stone. Ideal for preparing the surface for further protective treatment.

Directions for Use

Important: Always clean the entire surface because slight alterations in appearance are possible. Always test the product for suitability on a cut off.

Apply the undiluted product to the the dry surface and distribute evenly. After 4 to 10 minutes, rub off with a dry cloth or towel, then rinse with plenty of water and allow to dry.

Please Note: in case of very stubborn marks, such as imprints of vacuum lifting pads, stickers, etc. choose a longer working time.

Do not use on sensitive surfaces like rubber, paint, varnish, plastic and similar synthetics. Wash off splashes immediately.

Application Temperature: the surface temperature should be between +10 and +25°C.

Coverage: up to 10 m²/L

Storage

Closed, cool and dry. Temperature not to exceed 25°C. Shelf life of up to 2 years.

Environmental Protection

Free of CHCs. The contained surfactants are biodegradable according to regulation (EC) No. 648/2004 (detergents regulation).

Disposal: waste code according to EWC/AVV 07 01 04*.

Bottles/canisters are made of environmentally friendly tinplate and can be recycled (see information on label).

Safety

No health concerns once the surface has dried.
