Official Rules

- 1. SWEEPSTAKES PERIOD: The "RV Parts to Go Dream Camping and RV Accessories Giveaway" (herein referred to as the "Sweepstakes") begins on or about 12:00:01 a.m. Eastern Time ("ET") on November 4, 2021 ("Start Date") and ends on November 4th,2022, at 12:00:01 a.m. ET or once two hundred and fifty (250) entries have been received, whichever comes first (the "Promotion Period"). The official clock for the purpose of this Sweepstakes is the computer of the Sponsor. It is recommended that that any potential entrant consult the website at https://rvpartstogo.ca/pages/solar-panel-giveaway before entering to confirm the Sweepstakes is still active and that the Promotion Period has not concluded.
- 2. ELIGIBILITY: The Sweepstakes is open to legal residents of Canada (excluding the Province of Quebec), who are eighteen (18) years of age or older (exceptions: must be 19 years or older for those that reside in the provinces of British Columbia, New Brunswick, Newfoundland, Nova Scotia, Northwest Territories, Nunavut, and Yukon) as of the date of entry. Officers, members, directors, shareholders, agents and employees of RV Parts to Go (the "Sponsor"), a business operated by Buttermilk Falls Inc. ("Buttermilk Falls"), and any of their respective parent companies, affiliated companies, subsidiaries, dealers, franchisees, licensees, distributors, suppliers, participating retailers, advertising/promotion/judging agencies, persons engaged in the development, production or distribution of materials for this Sweepstakes (collectively, the "Released Parties" or "Releasees"), and the immediate family members (defined as spouse, parents, grandparents, children, grandchildren, siblings, whether biological, adopted, step or in-law) of such individuals, or persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Sweepstakes. Any amount spent by the purchaser over the gift card value will receive an entry based on the purchased item (Example 1 purchase using a giftcard: purchase \$150 worth of product using a \$50 gift card and receive 2 entries into the Sweepstakes, the \$50 from the giftcard does not apply towards an entry, but the remaining \$100 paid does constitute 2 entries. Example 2 purchase using no giftcard: purchase \$150 worth of product using a method other than giftcard and receive 3 entries).
- b. By visiting https://rvpartstogo.ca/pages/rewards-program and becoming a new member of the Rewards Program, members will receive 250 reward points, equaling a credit worth \$5. Members have the option to use said credit towards purchasing items relating to the Sweepstakes.
- 2) Mail-in Ballot: Individuals may enter by handwriting on a 3"x5" card/paper: "RV Parts to Go Dream Camping and RV Accessories Giveaway entry", your first and last name, address, city, province/territory, zip/postal code, telephone number, e-mail address, and date of birth. Insert the card into a standard business-size envelope with a handwritten return address (including entrant's first and last name) and mailing address on the front of the envelope and mail to: "RV Parts to Go Dream Camping and RV Accessories Giveaway", 635605 Hwy 10 (ON-10), Mono, ON Canada L9V 0Z7. All mail-in entries must include all requested information and format (as stated above) to be considered a valid entry. Bulk shipments (multiple entries in one shipping package), mail-in entries sent in larger than standard business-size envelopes and/or weighted envelopes will not be accepted and will be destroyed. Each valid mail-in entry will receive five (5) Sweepstakes entries. Mail-in entries will be counted once received by the sponsor and must be received by the end of the Promotion Period (once two hundred and fifty (250) entries have been received) to be valid. By participating in the Sweepstakes and providing any contact information, Participants hereby agree to the Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted the Sponsor's Privacy Policy.
- **5. 6. PRIZE: The selected Participant ("**Prize Winner**") will receive one (1) "Weekender ISW Solar Charging System (190 Watts)" (the "**Prize**") with an Approximate Retail Value ("**ARV**") of \$1,950.00 CAD (subject to change). There is one (1) Prize to be awarded during the Promotion Period.

7. WINNER SELECTION: One Prize Winner will be selected from among all eligible entries received, in a random draw within two (2) weeks after the conclusion of the Promotion Period. The random draw will be conducted by the Sponsor, whose decisions are final and not subject to challenge and/or appeal in all matters relating to this Sweepstakes. Should the potential winner decide to decline the Prize for any reason whatsoever, Sponsor shall have no further obligation to that potential winner, and an alternate potential winner will be selected, if time permits.
