**Personal Protective Equipment (PPE):**

Protective clothing against cuts to the neck, wrists, lower thigh area & Achilles tendon:

**Cut Protection Tops:** Blade Pro Base Layer Long Sleeve 2.0, AY00089 & AY00090 & AY00101

**Cut Protection Pants:** Blade Pro Base Layer Pants 2.0, AY00093, AY00094, AY00095 & AY00099

**Material composition tops:**

Upper body and upper arms: 79% polyamide / 21% elastane, 153g/m<sup>2</sup>

Cut protection inserts: 65% polyethylene / 14% polyester / 13% elastane / 8% glass

Lining: 76% polyamide / 24% elastane

**Material composition pants:**

Upper material hip and thigh: 65% polyamide / 35% elastane, 190/m<sup>2</sup>.

Upper material lower leg: 93% polyester / 7% elastane

cut protection inserts: 65% polyethylene / 14% polyester / 13% elastane / 8% glass

Lining: 95% polyamide / 5% elastane

**Care Labeling:**



Normal wash 40° C

Do not bleach

Dry with reduced thermal load

Do not iron

Dry cleaning not possible

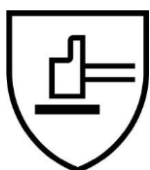
**Size:** see identification label

**Field of application:**

The protective clothing meets the requirements of Regulation (EU) 2016/425 with regard to personal protective equipment (PPE). The type test carried out shows that the PPE complies with the standards EN ISO 13688:2013+A1:2021 - Protective clothing - General requirements - and the test principle 2021/1, RevSta1 - Protective clothing - Personal protective equipment with protection against cuts. Cut protection test was performed according to the Coupe test. Performance level 4 was achieved - the highest cut protection is provided by performance level 5.

**Protection against the following risks:**

Underwear for playing ice hockey with inserts to protect cuts on the neck, wrists, lower thigh area and Achilles tendon that can be caused by skate blades.



**Sizes:**

The PPE is offered in men's sizes S, M, L, XL, XXL; women's sizes XS, S, M, L, XL; and children/youth sizes S/128, M/140, L/152, XL/164.

**Tops:** Neck and wrists are fully covered by the cut-resistant inserts for all sizes.

**Pants:** The lower part of the thighs and the Achilles tendon are fully covered by the cut-resistant inserts in all sizes.

**As a user of the protective clothing, please observe the following instructions:**

The protective clothing protects against cuts from skate blades in the areas of the neck, wrists, lower thigh area and Achilles tendon. All other body parts are not protected by cut protection surfaces and must be protected by additional protective clothing. Product must be washed before first use.

**Care instructions:**

Please do not use fabric softener and bleach in textile care.

**Inspection:**

Check for damage before use. Damaged protective clothing must not be used and must be disposed of! Damaged protective clothing must be discarded!

**Maintenance:**

Repairs to the PPE must be carried out by the manufacturer. Attention must be paid to the use of original yarn/materials!

**Storage:**

Store in a ventilated room, protected from direct UV and sunlight and dry!

**Expiration date:** No information / The expiration time depends on the degree of wear, use and field of application.
