Protective gloves - Wrist guards to prevent cuts to wrists:

**Blade Pro Wrist Guards, AY00091**

Cut protection upper material: 65% polyethylene / 14% polyester / 13% spandex / 8% glass  
Lining: 65% polyamide / 35% spandex, 190/m<sup>2</sup>

**Care label:**



Normal wash 40° C  
Do not bleach  
Dry flat  
Do not iron  
Dry cleaning not possible

**Size:** see identification label

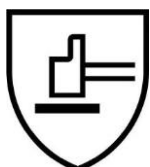
**Range of use:**

The protective gloves - wrist guards meet the requirements of Regulation (EU) 2016/425 regarding personal protective equipment (PPE).

The type test carried out shows that the PPE complies with the standards EN ISO 21420:2020 (DIN EN ISO 21420:2020-06) - Protective gloves - General requirements and test methods EN 388:2016+A1:2018 (DIN EN 388:2019-03) - Protective gloves against mechanical risks. Cut protection test was performed according to the Coupe test. Performance level 4 was achieved - the highest cut protection is provided by performance level 5.

**Protection against the following risks:**

Wrist guards for playing ice hockey with inserts to protect against cuts to wrists that may be caused by skate blades.

The marking "X" instead of a number means that the glove has not been tested for the corresponding risk.

Marking: Pictograms with performance levels 1-4, for cut resistance (6.2) 1-5, where a higher number means better protection.

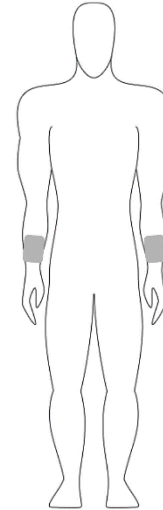
Sizes JR-Junior and SR-Senior offered.

**As a user of the protective gloves - wrist guards, please observe the following instructions:**

The wrist guards protect against cuts from skate blades in the wrist areas. All other parts of the body are not protected by cut guards and must be protected by additional protective clothing. Product must be washed before first use.

**Care instructions:**

Please do not use fabric softener or bleach in textile care.

**Inspection:**

Check for damage before use. Damaged protective gloves - wrist guards are not to be used and are to be disposed of!

Damaged wrist guards are to be discarded!

The expiry time depends on the degree of wear, use and area of application.

**Maintenance:**

Repairs to the PPE must be carried out by the manufacturer. Attention must be paid to the use of original yarn!

**Storage:**

Store in a ventilated room, protected from direct UV and sunlight and dry!

**Expiry date:** No information / The expiry time depends on the degree of wear, use and field of application.
